Booking: Confirmation of booking will be made upon receipt of the filled booking form and a deposit of 50% of the course fee.

Payment: The balance must be done four weeks before the course commencement date. If the balance of the course is not received at this time, your place on the course is not guaranteed. Bookings made within two weeks course commencement date must be paid in full.

Cancellation by the customer: If the cancellation notice is given more than four weeks only the deposit will be forfeit. Any cancellation made within four weeks prior the course commencement date will result in loss of payment.

Cancellation by Venice4Sea: Any course fee you have paid, including the deposit, will be refunded in full.

Refunds: Venice4Sea is not responsible for unused air tickets or unused portions of those or unused services of any kind.

Student Negligence: Any irresponsible behavior of a student leads to damage or loss any item of school or boat property, the student is responsible of replacement or repair.
